Statement: Election regulations for the elections to the student body of HS Schmalkalden from Jun 19, 2018:

§ 6 Election proposals

- (1) An election proposal consists of the proposal of an individual candidate or of a list of nominations.
- (2) An election proposal must include the candidate's last name, first name, faculty, full address, university e-mail address, and a written declaration of consent to stand for election.
- (3) Each election proposal must be supported by at least ten students entitled to vote and must be signed by at least ten students, indicating their surname, first name, faculty, number of semesters and full address. In the case of both individual and list election proposals, the candidates shall be considered to be supporters of their own election proposal and their own list at the same time.
- (4) A candidate may only be named on one nomination for the election of a committee. A supporter may only support one candidate at a time for the election of the student council. In case of duplication, the most recently submitted nomination shall apply. If, when the ballot box is emptied, it is not possible to determine which ballot was last submitted, the decision shall be made by drawing lots. Several nominations may be supported for the election of the student representatives.

(5) The election proposals must be submitted in writing to the election committee within 10 lecture days after expiry of the objection period for the electoral roll, unless the election committee has specified an extension of the deadline. In the winter semester 2020/2021, election proposals can be submitted until 27.11.2020. Note from the election leader.

(6) The election committee examines the submitted election proposals for completeness, correctness and timely submission. Incomplete or incorrect election proposals must be returned without delay with reference to existing deficiencies. They may be corrected within the period of time specified in section (5).

(7) After expiry of the submission period, the election proposals will be published by the election committee.

(8) Objections to the admission, deletion and mistakes in the publication of election proposals must be submitted in writing to the election committee within five days of publication. The Electoral Board shall decide on the objection without delay.
